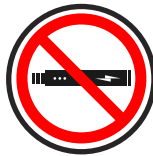

dancer_192021 E-cigarette means “an electronic cigarette or any other device that simulates smoking by using a mechanical heating element, battery, or electronic circuit to delivery nicotine or other substances to the individual inhaling from the device [including products sold as] e-cigarette, e-cigar, or e-pipe or under another product name or description [and including any] component, part, or accessory for the device [whether or not] sold separately . . .”¹

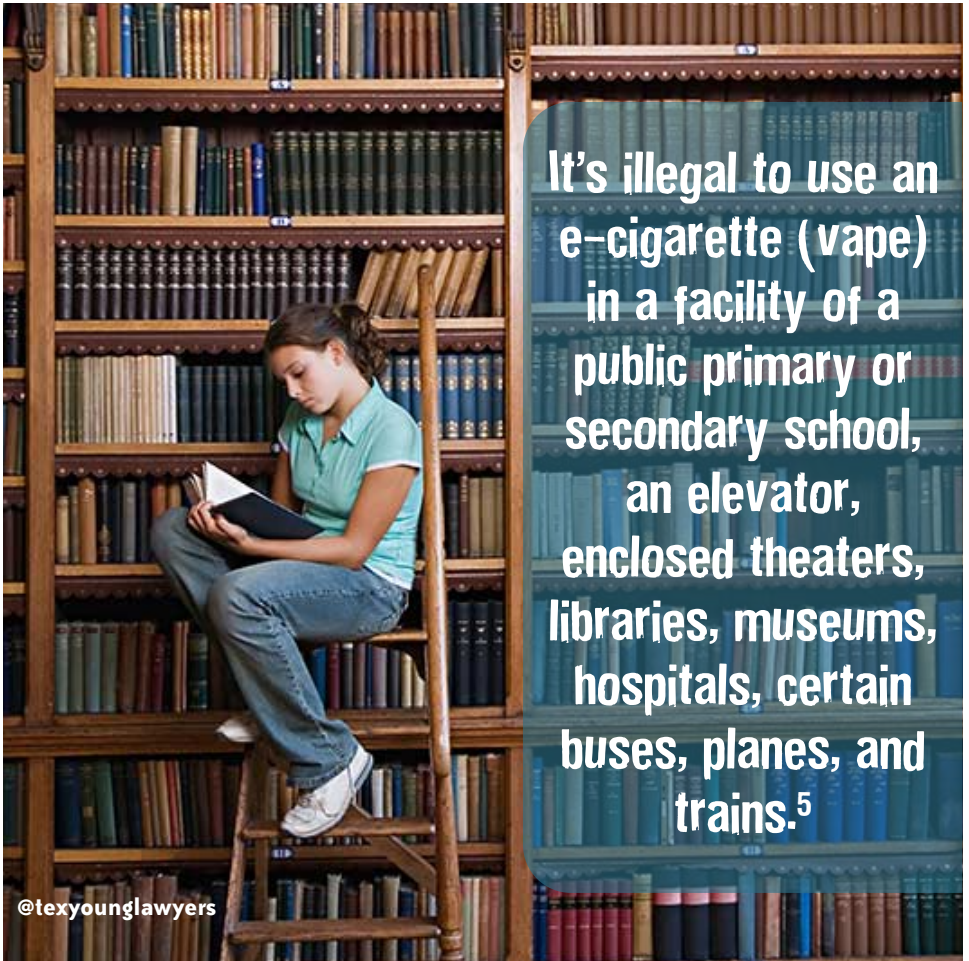

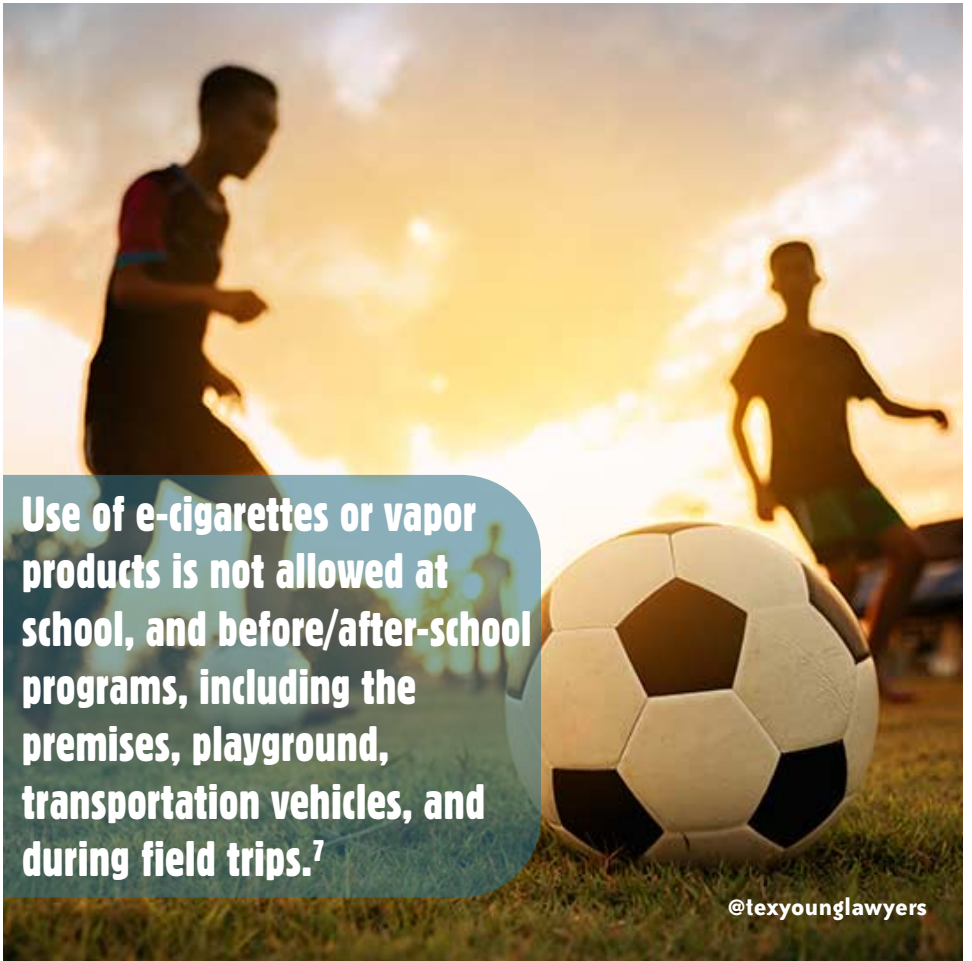
